2. Minutes of the Thirteenth Annual General Meeting held on 14 September 2022

The minutes had been previously circulated to all members of the Society. No questions/queries were received, and they were approved unanimously as an accurate record.

3. To receive and accept the Report of the Trustees

Ann also thanked Pam Eyton who has contributed so much to TASO over the years as a previous Secretary, provided key technical expertise during the delivery of online events and has now handed over her IT responsibilities.

Finally, Ann thanked the members for their support, and welcomed the new members.

The Report was approved and agreed unanimously.

4. To receive and accept the Annual Accounts as per 30 June 2023 A copy of the Financial Statements, including the annual accounts, had been circulated prior to the meeting. The copy circulated had not been signed off by the independent financial examiner due to a timing issue, but this has now been done, with no changes made to the document circulated.

The Treasurer explained that the Society still has a higher balance than it needs (due to lower than normal expenditure over the period of lock-down), and that this will continue to be run down over the next year. Accordingly, this year the Society's expenditure has exceeded its income. In particular, the Society has increased the amount of money it gives to local charities, some free activities have been provided to members, and the cost of the garden party was subsidised. David confirmed that the finances of the Society are in a very healthy state.

The adoption of the annual accounts was approved and agreed unanimously.
