Finally, Ann made her farewell as Chair and thanked the members for their support.

The Report was approved and agreed unanimously.

**4. To receive and accept the Annual Accounts as per 30 June 2024** A copy of the Financial Statements, including the annual accounts, had been circulated prior to the meeting. These had been signed off by the independent financial examiner.

The Treasurer confirmed that the annual accounts had been signed and submitted to the Charity Commission. The Society had broken even in the current financial year, with a total income of £42,298, and expenditure of £42,706. (In the previous year, there had been a loss of approximately £12k, planned to reduce the surplus created by the Covid period.) The reserves stand at approximately £27k.

The adoption of the annual accounts was approved and agreed unanimously.
